Sharpe Ratio: Average return earned in excess of the risk-free rate per unit of volatility or total risk. Subtracting the risk-free rate from the mean return, the performance associated with risk-taking activities can be isolated.

Sortino Ratio: Measures the risk-adjusted return of an investment asset, portfolio, or strategy. It is a modification of the Sharpe ratio but penalizes only those returns falling below a user-specified target or required rate of return, while the Sharpe ratio penalizes both upside and downside volatility equally.

Standard Deviation Known as historical volatility and is used by investors as a gauge for the amount of expected volatility. Upside Capture Ratio: Statistical measure of an investment manager's overall performance in up-markets. The up-market capture ratio is used to evaluate how well an investment manager performed relative to an index during periods when that index has risen. Downside Capture Ratio: Statistical measure of an investment manager's overall performance in down-markets. It is used to evaluate how well an investment manager performed relative to an index during periods when that index has dropped.

An upside capture ratio over 100 indicates a fund has generally outperformed the benchmark during periods of positive returns for the benchmark. Meanwhile, a downside capture ratio of less than 100 indicates that a fund has lost less than its benchmark in periods when the benchmark has been in the red. A negative downside capture indicates the fund has gained when its benchmark has been in the red. All bond funds' ratios are calculated relative to the Barclays Capital U.S. Aggregate Bond

Leader Capital Corp

A short duration bond fund that gives investors exposure across multiple fixed income sectors and a focus on low duration.

Launched in 2005, Leader Short Duration Bond Fund has focused on maximizing total return potential through the ups and downs of bond market cycles, while maintaining a low overall duration. The Fund holds a diversified portfolio of bonds across various fixed income sectors that is actively managed to maximize return and generate a high level of income.

A Broader Opportunity Set: The fund invests in a diversified portfolio of short duration, investment-grade, money market and other fixed income securities.

Opportunistic Approach: The Fund's experienced managers look for strategic entry points across asset classes and single securities.

Higher Income Potential: Access to a wider range of income opportunities means the fund may offer higher income potential than other short-term investments.

Market & Fund Commentary

Market volatility continued on right into April. We saw equity markets rally to start the month before giving back almost all of the months gains. It seems that the broader stock market indices are trading within a narrowing range, with the S&P consistently finding support at its 200-day moving average while making lower highs. High yield spreads remain elevated but also within a range. Interestingly enough, investment grade corporate spreads have widened more than high yield has from its January tights (HY spreads wider by ~18% from January tights; IG spreads wider by ~39% from January tights).

We saw the dollar rally from its lows of the year, which seems to be a headwind to the equity markets. We believe the dollar move has also helped support rates from running away to the upside.

The portfolio remains similar to last month from the top level as we continue to maintain higher credit quality and taking advantage of opportunities across various fixed income sectors to generate yield. We've reduced floating rate exposure over last month and shifted it over to exposure to Agency Mortgages and Convertibles. We feel comfortable moving some exposure away from floating rate bonds into other areas of fixed income with comparable yields and limited interest rate sensitivity.

While we have the portfolio generally more defensive, we have made sure to maintain exposure to segments of the market that can still provide upside potential and yield.

Definitions:

S&P 500: Standard and Poor's 500 Index is a capitalization-weighted index of 500 stocks. The index is designed to measure performance of the broad domestic economy through changes in the aggregate market value of 500 stocks representing all major industries. The index was developed with a base level of 10 for the 1941-43 base period.
