Sharpe Ratio: Average return earned in excess of the risk-free rate per unit of volatility or total risk. Subtracting the risk-free rate from the mean return, the performance associated with risk-taking activities can be isolated.

Sortino Ratio: Measures the risk-adjusted return of an investment asset, portfolio, or strategy. It is a modification of the Sharpe ratio but penalizes only those returns falling below a user-specified target or required rate of return, while the Sharpe ratio penalizes both upside and downside volatility equally.

Standard Deviation Known as historical volatility and is used by investors as a gauge for the amount of expected volatility.

Upside Capture Ratio: Statistical measure of an investment manager's overall performance in up-markets. The up-market capture ratio is used to evaluate how well an investment manager performed relative to an index during periods when that index has risen.

Downside Capture Ratio: Statistical measure of an investment manager's overall performance in down-markets. It is used to evaluate how well an investment manager performed relative to an index during periods when that index has dropped.

An upside capture ratio over 100 indicates a fund has generally outperformed the benchmark during periods of positive returns for the benchmark. Meanwhile, a downside capture ratio of less than 100 indicates that a fund has lost less than its benchmark in periods when the benchmark has been in the red. A negative downside capture indicates the fund has gained when its benchmark has been in the red. All bond funds' ratios are calculated relative to the Barclays Capital U.S. Aggregate Bond Index.

A total return bond fund that gives investors exposure across multiple fixed income sectors and a focus on total return.

Launched in 2010, Leader Total Return Fund has focused on maximizing total return potential through the ups and downs of bond market cycles. The Fund is a diversified portfolio of bonds across various fixed income sectors that is actively managed to maximize return and generate a high level of income.

A Broader Opportunity Set: The fund invests in a diversified portfolio of fixed income securities across multiple asset classes, taking advantage of dislocations and opportunities across various sectors.

Opportunistic Approach: The Fund's experienced managers look for strategic entry points across asset classes and single securities.

Higher Income Potential: Access to a wider range of income opportunities means the fund may offer higher income potential than other short-term investments.

Market & Fund Commentary

Equity markets opened the month higher before all the headlines hit and caused a downward move for the back half of the month. The federal reserve raised interest rates for a second time this year by a quarter point to a new range of 1.75% to 2.00%. The main headline that caused volatility were trade wars with China and tariffs with the rest of the world. Emerging markets ("EM") continue to feel pain as the dollar move has hit EM risk assets across the board from equities to bonds. U.S. fundamental data shows no cracks as of now. Unemployment printed 3.8% last month. Core US Personal Consumption finally hit 2.0%, which is a key level the Federal Reserve has noted for continued rate hikes. Major Indices are mixed in holding key support levels. To end the quarter, the Dow Jones closed below its 200-day moving average, while S&P500 and Nasdaq both held their 50-day moving averages.

High Yield Credit spreads ticked wider (+9bps) over June from May. Investment Grade spreads continued to tick wider (+1bps) after ticking wider last month as well. Interest rates remain especially volatile. After a large rally in May, treasuries began giving back gains with yields across the curve moving higher. However, with all the trade tension arising in the back half of the month, we saw yields trickle back lower and the yield curve continue to flatten. LIBOR remains around 2.3%, which is unchanged over last month. The Federal Reserve remains committed to its rate hikes, whether it be 3 total or 4 total this year. Though yields fell in the month of May, they have since ticked back higher and it is our view that the longer term trend is still higher. We remain cautious on longer duration bonds as well as the front end of the curve. In the front end, we still favor floating rate bonds.

The portfolio remains similar to last month from the top level. We continue to take advantage of yields within Agency Mortgage bonds and CLO Equity tranches. This month, we largely left the portfolio changes from last month the same.

We continue to look for opportunities across asset classes. High yield corporates continue to trade at yields not worth the risk. We are monitoring Emerging markets, but need to some stability first. Adding duration could be on table as well. We continue to monitor inflation expectations and key technical levels on the 10-Year US Treasury yield for entry points.

Definitions:

S&P 500: Standard and Poor's 500 Index is a capitalization-weighted index of 500 stocks. The index is designed to measure performance of the broad domestic economy through changes in the aggregate market value of 500 stocks representing all major industries.

CLOs: Collateralized loan obligations (CLOs) are a form of securitization where payments from multiple middle sized and large business loans are pooled together and passed on to different classes of owners in various tranches. A CLO is a type of collateralized debt obligation.

Basis Point ("bps"): one hundredth of one percent, used chiefly in expressing differences of interest rates
