Sharpe Ratio: Average return earned in excess of the risk-free rate per unit of volatility or total risk. Subtracting the risk-free rate from the mean return, the performance associated with risk-taking activities can be isolated.

Sortino Ratio: Measures the risk-adjusted return of an investment asset, portfolio, or strategy. It is a modification of the Sharpe ratio but penalizes only those returns falling below a user-specified target or required rate of return, while the Sharpe ratio penalizes both upside and downside volatility equally.

Standard Deviation: Known as historical volatility and is used by investors as a gauge for the amount of expected volatility.

Upside Capture Ratio: Statistical measure of an investment manager's overall performance in up-markets. The up-market capture ratio is used to evaluate how well an investment manager performed relative to an index during periods when that index has risen.

Downside Capture Ratio: Statistical measure of an investment manager's overall performance in down-markets. It is used to evaluate how well an investment manager performed relative to an index during periods when that index has dropped.

An upside capture ratio over 100 indicates a fund has generally outperformed the benchmark during periods of positive returns for the benchmark. Meanwhile, a downside capture ratio of less than 100 indicates that a fund has lost less than its benchmark in periods when the benchmark has been in the red. A negative downside capture indicates the fund has gained when its benchmark has been in the red. All bond funds' ratios are calculated relative to the Barclays Capital U.S. Aggregate Bond Index .

A high quality bond fund that gives investors exposure across multiple fixed income sectors, a focus on high credit quality, and low duration.

Launched in 2016, Leader High Quality Low Duration Bond Fund is focused on maintaining superior portfolio credit quality. The Fund is actively managed for strong risk adjusted returns, high portfolio credit quality, minimal interest rate sensitivity and ability to invest across fixed income sectors.

High Credit Quality: The Fund invests in A or better rated securities only. We view our high quality mandate is crucial to reducing volatility and vital to being a core fixed income holding.

Diversified Across Asset Classes: Access to a wider range of floating rate securities means the fund may take advantage of dislocations across the market to generate incremental yield.

Floating Rate Exposure: Participate with rising rates. A bond fund that achieves its low duration mandate through investments in floating rate bonds.

Fit for Multiple Categories: A fund that can serve as an ultrashort bond fund, short term bond fund, and an investment grade floating rate fund. The Fund's low duration and high-quality mandate make this fund a fit for multiple Morningstar fixed income categories.

Market & Fund Commentary

Equity markets rebounded back in October as trade fears alleviated. The Dow, Nasdaq, and S&P are well above their 200-day moving averages and trending higher. The trade deal made some positive headway over the past month. The Federal Reserve cut rates again in October for the third time year. We believe that lower interest rates have been the main driver of equity markets. Earnings have been good enough, but not great. We continue to believe a generally defensive posture is warranted and tactically adding risk.

High Yield credit spreads tightened over October from September (-13bps) following equity markets. Investment Grade spreads also tightened over October from September (-5bps). The yield curve normalized further during October as rates continued their roller coaster moves, largely due to markets digesting the Federal Reserve. The 2yr treasury yield decreased MoM from 1.624% to 1.527%. For the first time in quite some time, 2yr and 5yr US Treasury yields are no longer inverted. The 2yr and 10yr yield has continued to normalized after the Federal Reserve cut the Federal Funds rates again; now 18bps apart. The 10yr treasury yield increased MoM from 1.666% to 1.692% (with its widest point at 1.843%). We continue to believe it prudent to maintain credit quality, but at the same time, be nimble enough to step in on any beaten down opportunities.

We made some changes this month as we are looking to shore up any potential downdrafts in the portfolio even through AA rated credits. We sold our longest weighted average life AAA and AA bonds and are looking to deploy the proceeds into the shortest AAA rated bonds. We currently like extremely short AAA exposure as these bonds are currently amortizing and we can receive proceeds back quarterly. Overall, we continue to remain very short in our credit exposure. We continue to highly favor credit quality as the portfolio remains highly defensive, but we continue to see pockets of opportunity now in short WAL ("weighted average life") AAA bonds and upgrade candidates.

Definitions:

S&P 500: Standard and Poor's 500 Index is a capitalization-weighted index of 500 stocks. The index is designed to measure performance of the broad domestic economy through changes in the aggregate market value of 500 stocks representing all major industries.

Dow Jones Transportation Index: The Dow Jones Transportation Average is a price-weighted average of 20 U.S. transportation stocks. The average as it is known today began on October 26, 1896. It was formerly known as the Dow Jones Railroad Average..

CLOs: Collateralized loan obligations (CLOs) are a form of securitization where payments from multiple middle sized and large business loans are pooled together and passed on to different classes of owners in various tranches. A CLO is a type of collateralized debt obligation.

Basis Point ("bps"): one hundredth of one percent, used chiefly in expressing differences of interest rates
