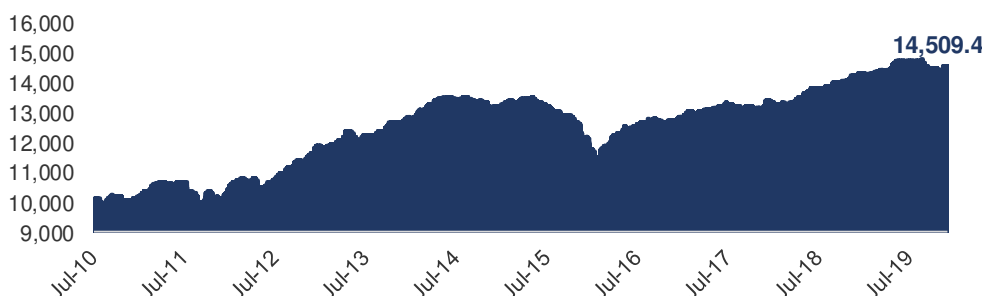
### A total return bond fund that gives investors exposure across multiple fixed income sectors and a focus on total return.
