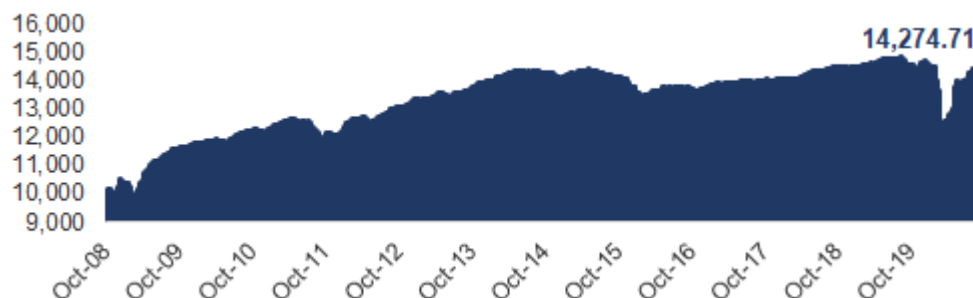
### A short duration bond fund that gives investors exposure across multiple fixed income sectors and a focus on low duration and yield.
